ADDITION TO THE EXISTING POSITIONS PROVIDED IN THE LOCAL  
GOVERNMENT CODE OF 1991.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of a  
letter dated 16 March 1992 from the Honorable City Mayor requesting for  
a legislative action creating the following Mandatory Positions for  
Cities to be included in the Plantilla of Personnel for 1992, namely:
