A RESOLUTION AUTHORIZING THE HOMORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY COVERNMENT, A MEMORANDUM OF AGREEMENT WITH THE ROTARY CLUB OF ORMOC FOR THE LATTER'S CONSTRUCTION OF A MULTI-PURPOSE CENTER BUILDING AT BRGY. TAMBULILID, ORMOC CITY.

WHEREAS, this august Body is in receipt of a letter dated 14 August 1992 from the Rotary Club of Ormoc, addressed the Honorable City Mayor through the Honorable Sangouniang Panlungsod, requesting for a specific site within the open space of the relocation site of the victims of typhoon Uring at Broy. - That the City Government will provide a lot at the relocation site of flood victims of typhoon Uring in Brgy. Tambulilid, this city, containing an area of 100 square meters, more or less, on where the Multi-Purpose Center building be constructed according to the sketch plan and specifications submitted by the Club;
- b) The construction shall be undertaken by the Rotary Club of Ormoc at their own expense and upon completion of the construction of the building or project, the said building be turned over to the City Government of Ormoc for latter to decide who can use it later on; and
- health Requirements on building permit, fire, sanitation, etcetera shall be complied with by the Club
