A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE
AGAINST CURRENT APPROPRIATION ON TRAVELLING EXPENSES OF
THE MUNICIPAL TRIAL COURT IN CITIES, THIS CITY, THE AMOUNT
OF P1,046.52, TO SETTLE THE 1991 OUTSTANDING OBLIGATION ON
TRAVELS INCURRED BY THE HONORABLE TRIAL JUDGE THEREOF.

WHEREAS, to be considered for charging against Current
Appropriation on Travelling Expenses is a written request of the
Honorable Judge Buenaventura C. Vilbar, Municipal Trial Court in Cities
(MTCC), this city, for an amount of P1,046.52 to be made available for
settlement of the 1991 outstanding obligation on travels re
reimbursement of travelling expenses while attending a Dialogue-Seminar
of Judges & Ratification of Constitution & By-Laws, City Judges
Association - Philippines, in Cebu City, December 6 -7, 1991, incurred by
the Honorable Trial Judge of said court;

be it


