3.3 KMS., C) ORMO NAUNGAN LAO ROAD 5.3 KMS., AND D)
LILLOAN BALION SABANG ROAD 6.4 KMS. FOR PURPOSES OF
ISSUANCE OF NEDA/ICC CLEARANCES.

WHEREAS, the Regional Director (OIC), Department of Public Works
and Highways, Region VIII, Tacloban City, has sent a radio message to
the DPWH City Engineer, this city, copy furnished the Honorable
