RESOLUTION NO. 5

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR MA. VICTORIA L. LOCSIN TO GRANT THE OCCUPANTS OF ORMOC SHOPPING MALL WITH WAIVER ON RENTAL FOR THE CALAMITY MONTH OF NOVEMBER, 1991 ONLY.

WHEREAS, the occupants of Ormoc Shopping Mall, through their letter addressed Her Honor, the City Mayor dated 20 December 1991, have petitioned the government, among others, for waiver of rental payments for the months of November and December, 1991 and for the status quo of rental until such time that they can recover from losses due to typhoon Uring;

WHEREAS, the Honorable Mayor Ma. Victoria L. Locsin has written a letter to the Honorable Sangguniang Panlungsod, the full text of said letter is hereunder cited as follows:

Gentlemen:

Attached please find a petition of the Shopping Mall occupants for the waiver of the November and December, 1991 rentals. Our rentals thereat amounts to P558,000 per year or P46,500 per month.

As a concession to their request, it is recommended that only the rental for the month of the calamity be waived. It is therefore requested that an authority be granted to the undersigned for this purpose.
