RESOLUTION NO. 50

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR TO ADVISE AND EFFECT THE CEMENTING OF TU-OG ROAD FROM THE FATIMA ROAD DOWN TO THE TU-OG ROAD OF BRGY. DONA FELIZA MEJIA, THIS CITY, AS REQUESTED BY THE BARANGAY COUNCIL OF SAID BARANGAY.

WHEREAS, this august Body is in receipt of Resolution No. 6 s. 1992 from the Barangay Council of Brgy. Dona Feliza Mejia, this city, requesting the Honorable City Mayor to intercede for and cause the cementing of the Tu-og road from Fatima road down to the Tu-og road of the said barangay;

WHEREAS, the aforecited resolution has stated further that " the road in this area are already dilapidated and damaged and such adverse conditions are inconvenient to the movements of persons, goods and commerce within the barangay";

WHEREAS, per SP Resolution No. 92 s. 1992 which has adopted the 1992 CDC Additional 20% EDF Projects and through Resolution No. 93 s. 1992 embodying Appropriation Ordinance No. 92-19, this concreting of a road at Brgy. Dona Feliza Mejia is supposedly from the highway to the chapel of said barangay, however, findings have shown that the road to be concreted is a subdivision road which not yet donated to the City Government;

NOW, THEREFORE, on a motion represented by Kagawad Sotero M. Pepito, Majority Floor Leader, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to request the Honorable City Mayor to advise and effect the cementing of Tu-og Road from the Fatima Road down to the Tu-og Road of Brgy. Dona Feliza Mejia, this city, as requested by the Barangay Council of said barangay;
