RESOLUTION NO. 51

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE
AMOUNT OF ₱2,014.00 AGAINST CURRENT APPROPRIATION - OTHER
SERVICES OF THE CITY MAYOR'S OFFICE, SAID AMOUNT BE MADE
AVAILABLE FOR REIMBURSEMENT OF THE MEDICAL EXPENSES
INCURRED BY MR. AND MRS. GEORGE TARROJA.

WHEREAS, a letter from Mr. George Tarroja dated 4 February 1992,
addressed Her Honor, the City Mayor, respectfully requesting for
reimbursement of the medical expenses incurred amounting to ₱2,014.00
as a result of the incident which took place last 15 January 1992;

WHEREAS, the City Legal Officer, upon investigation, has
established the following:

"The claimants Mr. Tarroja and his wife Ruvilla Tarroja,
on January 15, 1992 at about 9:00 in the evening, while riding
on a bicycle accidentally fell on an open manhole located in
front of the City Hall. The open manhole was not visible to
motorists at night as the street was not well lighted. As a
result of the accident Mr. Tarroja and his wife suffered
injuries as can be shown in their medical certificates and
other pertinent documents.

"This Office opined in the claim of BENEDICTO ALAMA
endorsed to the Sangguniang Panlungsod dated July 31, 1991 and
its legal basis is adopted herein for purposes of this claim.
(Resolution No. 139)."

WHEREAS, the City Budget Officer, through 4th Indorsement dated 13
March 1992, has requested for SP resolution granting authority to the
City Treasurer to charge against Current Appropriation on Other Services
account, Office of the City Mayor, the amount of ₱2,014.00 as
reimbursement for the medical expenses incurred by Mr. George Tarroja
and his wife;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Rodolfo L. Rivilla, Jr. and Edgar Z. Palugod; be it


