WHEREAS, this august Body is in receipt of a Resolution No. 1 s.  
1991 of the Ormoc YMCA, entitled, "A RESOLUTION REITERATING THE REQUEST  
OF THE YMCA, ORMOC, ADDRESSED TO THE HONORABLE CITY MAYOR, ORMOC CITY,

WHEREAS, the Sixth Sangguniang Panlungsod in SESSION, regrets to  
inform the Ormoc YMCA that the City Government of Ormoc cannot act

in Ormoc City;


