RESOLUTION NO. 53

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ENTER INTO A 25-YEAR LEASE CONTRACT, FOR AND IN BEHALF OF THE CITY GOVERNMENT, WITH THE ORMOC CITY MEDICAL SOCIETY OVER LOT NO. 2 WITH AN AREA OF 500 SQUARE METERS LOCATED AT THE CITY GOVERNMENT CENTER SITE FOR THE ESTABLISHMENT OF THE LATTER'S CHARITY CLINIC.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of a written request from the Ormoc City Medical Society for a parcel of land to be leased at the Government Center of at least 600 square meters, for the members of the society to build their medical clubhouse where they could "freely and singularly dispose of some urgent medical and other related services" to the community;

WHEREAS, the City Government has recommended that Lot No. 2 with an area of 500 square meters located at the Government Center be the subject of said lease, in lieu of Lot No. 2245 located across the road south of the 2nd Leyte Engineering District Office, (as embodied per SP Resolution No. 30 s. 1975), for the latter venue is currently reserved for the City Hospital site by the Honorable City Mayor;

WHEREAS, this august Body believes that the establishment of a charity clinic by the Ormoc City Medical Society will ultimately redound to the interest and general well-being of our constituents, more particularly to the destitutes and the needy;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, duly seconded by Kagawad Jose B. Conejos; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to enter into a 25-year Lease Contract, for and in behalf of the City Government, with the Ormoc City Medical Society over Lot No. 2 with an area of 500 square meters located at the City Government Center for the establishment of the latter's Charity Clinic;

CARRIED UNANIMOUSLY.


