RESOLUTION NO. 53

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN,  
FOR AND IN BEHALF OF THE CITY GOVERNMENT, AN AMENDED  
MEMORANDUM OF AGREEMENT WITH THE ROTARY CLUB OF ORMOC FOR  
THE LATTER'S CONSTRUCTION OF A MULTI-PURPOSE CENTER  
BUILDING AT BRGY. TAMBULILID, ORMOC CITY.

WHEREAS, Resolution No. 46 s. 1992 has been amended increasing to  
200 square meters the original area of 100 square meters of the lot set  
aside by the City Government at Brgy. Tambulilid, this city, for the  
construction of a Multi-Purpose Center building by the Rotary Club of  
Ormoc;

WHEREAS, this amended Resolution No. 46 has the following official  
expressions of this august Body, as follow:

"WHEREAS, this august Body is in receipt of a letter dated  
14 August 1992 from the Rotary Club of Ormoc, addressed the  
Honorable City Mayor through the Honorable Sangguniang  
Panlungsod, requesting for a specific site within the open  
space of the relocation site of the victims of typhoon Uring  
at Brgy. Tambulilid, this city, upon which to construct a  
Multi-Purpose building in connection with the Rotary Livelihood  
Center Project of the Rotary Club of Ormoc;

"WHEREAS, the said letter has further stated that their  
Club has already secured the plans and specifications of the  
building, with blue print of a sketch plan of the proposed site  
therein attached for perusal and approval by this august Body,  
"as the Club is determined to finish the project with the least  
possible delay, and after the completion of the multi-purpose  
building, the same be turned over to the City of Ormoc X X X X";

"WHEREAS, the Honorable MEMBERS of the SANGGUNIANG  
PANLUNGSOD ng ORMOC, in SESSION, has considered meritorious and  
laudable the open intention and willingness of service of the



Rotary Club of Ormoc, hence, be accorded with immediate and due course of action;"

NOW, THEREFORE, on a motion presented by Kagawad Sotero M. Pepito, Majority Floor Leader, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, AN AMENDED MEMORANDUM OF AGREEMENT WITH THE ROTARY CLUB OF ORMOC FOR THE LATTER'S CONSTRUCTION OF A MULTI-PURPOSE CENTER BUILDING AT BRGY. TAMBULILID, ORMOC CITY;

RESOLVED, FURTHER, that the aforecited Memorandum of Agreement shall contain the following conditions (as amended):

- a) That the City Government of Ormoc will provide a lot at the relocation site of flood victims of typhoon Uring in Brgy. Tambulilid, this city, containing an area of 200 square meters, more or less, on where the Multi-Purpose Center building be constructed according to the sketch plan and specifications submitted by the Club;
- b) The construction shall be undertaken by the Rotary Club of Ormoc at their own expense and upon completion of the construction of the building or project, the said building be turned over to the City Government for the latter to decide who can use it later on; and
- c) Requirements on building permit, fire, health and sanitation, etcetera, shall be complied with by the Club.

ENACTED, August 27, 1992.

RESOLVED, FINALLY, to furnish copies of this resolution each to His Honor, the City Mayor, the City Administrator, the City Legal Officer, the City Planning & Development Office, the City Engineer and the President - Rotary Club of Ormoc, all in Ormoc City;
