RESOLUTION NO. 54

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, IN HER CAPACITY AS CHAIRMAN, CITY DISASTER COORDINATING COUNCIL (CDCC), TO PURCHASE A PARCEL OF LAND LOT NO. 3479, COVERED BY TCT NO. 11304 SITUATED AT BRGY. SAN ANTONIO, ORMOC CITY, WITH AN AREA OF 3,012 SQUARE METERS, @ P46.50/SQ. M., IN THE AMOUNT OF P140,000.00, TO BE FUNDED FROM THE CDCC FUNDS.

WHEREAS, presented to be considered for purchase is a parcel of land Lot No. 3439 of the Cadastral Survey of Ormoc, covered by Transfer Certificate of Title No. 11304, owned by Spouses Felipe Cuarenta and Fernanda Codog - Cuarenta, situated in Brgy. San Antonio, this city, with an area of 3,012 square meters @ P46.50/sq. m., in the amount of P140,000.00;

WHEREAS, the City Disaster Coordinating Council of Ormoc is still in need of additional relocation site/s for the flood victims due to typhoon Uring and on where the CORE Shelters of DSWD be established;


