RESOLUTION NO. 55

A RESOLUTION OF CONCURRENCE TO THE REMOVAL OF SHIPPING
CONTAINER VANS DEPOSITED UPSTREAM OF THE CITY PROPER OR
NORTH OF THE CITY AND HAVE THEM TRANSFERRED TO THE OPEN
SPACE AT ORMOC - PPA AREA.

WHEREAS, three (3) Barangay Councils of Brgy. Districts Nos. 18, 19 and 20, this city, had presented to this august Body three (3) resolutions, one each, namely: a) Unnumbered Resolution s. 1991 from Brgy. District No. 18, b) Resolution No. 12 s. 1991 - Brgy. District 19, and c) Resolution No. 1 s. 1992 from Brgy. District No. 20, all these three resolutions are identical in their resolve and purpose on "EARNESTLY REQUESTING THE HONORABLE MEMBERS OF THE 5TH SANGGUNIANG PANLUNGSOD THROUGH THE HON. MA. VICTORIA L. LOCSIN, CITY MAYOR, ORMOC CITY, BANNING THE STORAGE OF SHIPPING CONTAINER VANS UPSTREAM OF THE CITY PROPER OR NORTH OF THE CITY", based on the following quoted premises:

"The last typhoon and flash flood lucidly demonstrated the adverse effects of the storage of container vans (shipping) at barangay 28, Zone 3, which caused untold damages worst than what the storm or flood caused in terms of property damage, both public and private, and lives, most notably along Bonifacio Street which was the route which vans with Aboitiz markings floated from Hermosilla Drive at which are said container vans were stored.

"Said vans demolished electric power lines posts, concrete fences, residential houses along Bonifacio Street, X X X X

"As observed in its erratic meandering downstream, everytime the 20-footer vans temporarily stops, it obstructed the flow of rampaging waters, rising to abnormal heights which severely damaged the houses on such particular areas."

WHEREAS, the City Legal Officer, through 4th Indorsement dated 20 January 1992, has opined that it is entirely within the powers of the City Government of Ormoc through that august Body to "regulate activities relative to the use of land, buildings and structures within the city" (Sec. 458, R.A. No. 7160) for the purpose of promoting the general welfare of its constituents. "Attention, however, of the Sangguniang Panlungsod is invited on the city's existing zoning ordinance which classifies the container yard referred to in Resolution 19 as commercial";

WHEREAS, through a Dialogue called for the purpose, attended to by the Honorable City Mayor, a Representative of the Aboitiz Shipping Lines and other officials/persons of the community believed with influence in solving the existing issue, a Consensus has cropped up on Removing the Shipping Container Vans stored at the Upper Portion of the City Proper or North of the City and have them transferred to the open space at the Philippine Ports Authority or Ormoc - PPA Area;

NOW, THEREFORE, on a motion presented by Kagawad Rodolfo L. Rivilla, Jr., severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Celso P. Porcadilla and Sixto T. Pongos; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a Resolution of Concurrence to the Removal of Shipping Container Vans deposited Upstream of the City Proper or North of the City and have them transferred to the open space at Ormoc-PPA Area;

ENACTED, March 26, 1992.




