## RESOLUTION NO. 55

A RESOLUTION RESPECTFULLY REQUESTING THE CONGRESS OF THE PHILIPPINES, THROUGH THE HONORABLE SENATE PRESIDENT AND THE SPEAKER, HOUSE OF REPRENTATIVES, TO AMEND SECTION 2, ARTICLE 6 OF THE PHILIPPINE CONSTITUTION, SO AS TO PROVIDE A REGIONALIZED ELECTIONS FOR MEMBERS OF THE SENATE, IN SUPPORT TO THE REQUEST OF THE SANGGUNIANG PANLUNGSOD OF GINGOOG CITY, MISAMIS ORIENTAL.

WHEREAS, this august Body is in receipt of Resolution No. 129 s. 1992 of the Sangguniang Panlungsod ng Gingoog, entitled, "REQUESTING THE HONORABLE HOMOBONO T.
