THE DEPARTMENT OF AGRICULTURE.

WHEREAS, an orientation on the Fisheries Sector Program was conducted last 27 August 1992 at the Sangguniang Panlungsod Session Hall, this city, by personnel of the Department of Agriculture - Fisheries Sector, Region 8 Regional Office;

WHEREAS, as rationale on the Fisheries Sector Program, consultations with the Local Government Units (LGUs) by the Department of Agriculture - Fisheries Sector Program is being undertaken pursuant to the 1991 Local Government Code, Section 26 and 27 thereof having required all National Government Agencies programs to conduct consultations with the LGUs prior to implementation;

WHEREAS, furthermore, Section 17 b, 2 of the Local Government Code has devolved responsibility for fishery management to the LGU and, in line with these new challenges, the Fisheries Sector Program aims to build up the capabilities of the LGU to manage its fishery resources, hence, LGU acceptance, support and participation in program implementation is very essential to the program's success;

NOW, THEREFORE, on motion of Kagawad Claudio P. Larrazabal, jointly seconded by mga Kagawad Mariano Y. Corro and Jose C. Alfaro, Jr., be it

RESOLVED, to pass a resolution ADOPTING THE FISHERIES SECTOR PROGRAM (FSP) OF THE DEPARTMENT OF AGRICULTURE;

ENACTED, August 27, 1992.



CARRIED UNANIMOUSLY.


