A RESOLUTION ENDORSING WITH FULL SUPPORT RESOLUTION NO. 105
S. 1992 OF THE SANGGUNIANG PANLUNGSOD NG BAKOLOD
REQUESTING THE PHILIPPINE NATIONAL POLICE (PNP), BACOLOD
CITY HEADQUARTERS, THRU THE STATION COMMANDER, COL.
NICOLAS M. TORRES, TO ASSIGN POLICEWOMEN IN THE CONDUCT OF
INVESTIGATION THAT WILL REQUIRE PERSONAL INTERVIEW WITH
WOMEN WHO HAVE BEEN VICTIMS OF SEXUAL CRIMES, AND ADOPTING
THE SAME.

WHEREAS, this august Body is in receipt of Resolution No. 105 s.
1992 of the Sangguniang Panlungsod ng Bakolod entitled "A RESOLUTION
REQUESTING THE PHILIPPINE NATIONAL POLICE (PNP), BACOLOD CITY

requesting the Philippine National Police (PNP), Bacolod City
Headquarters, thru the Station Commander, Col. Nicolas M. Torres, to
assign Policewomen in the conduct of investigation that will
require personal interview with women who have been victims of sexual
crimes, AND adopting the same;


