Kagawad Benjamin B. Lladoc and Alfredo F. Capahi; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City

ENACTED, September 3, 1992.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
