A RESOLUTION ENDORSING THE RESOLUTIONS OF BARANGAY QUEZON, JR. AND BARANGAY DISTRICT NO. 26, BOTH IN ORMOC CITY, TO THE HONORABLE SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT, MANILA, FOR HIM TO RESOLVE THE AMOUNT OF HONORARIA THAT BARANGAY OFFICIALS ARE ENTITLED TO RECEIVE.

WHEREAS, this august Body is in receipt of Resolution No. 3 and an Unnumbered Resolution, all 1992 Series, from the Barangay Council of Brgy. Quezon, Jr. and Barangay District No. 26, both in Ormoc City and respectively, both resolutions having requested the Honorable City Mayor of Ormoc for clarifications on the amount of Honoraria that Barangay Officials are entitled to receive:

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc, in SESSION, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, has decided to endorse the aforesaid resolutions to the Honorable Secretary, Department of Budget & Management, Manila, due to conflicting opinions given by the City Budget Officer and the DILG-ACGO Officer, wherein according to the DILG-ACGOO, a Punong Barangay is entitled to P1,000 and P600 for every Barangay Kagawad, to a Secretary and the Treasurer; the City Budget Officer, on the other hand, has said that the amount of P1,000 and P600 cannot be given if it does not conform or it will exceed the 55% limitations regarding the amount which would be appropriated for personal services;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by Kagawad Jose C. Alfaro, Jr. and Alfredo F. Capahi; be it
