RESOLUTION NO. 61

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE OVER LOT NO. 8-8-3 WITH MR. ARTURO COQUILLA, REGISTERED OWNER OF SAID LOT WITH AN AREA OF 238 SQUARE METERS SITUATED AT BRGY. DONA FELIZA Z. MEJIA, ORMOC CITY, AT P200.00 PER SQUARE METER, IN THE TOTAL AMOUNT OF P47,600.00 PURSUANT TO RESOLUTION NO. 52 S. 1992 EMBODYING APPROPRIATION ORDINANCE NO. 92-09.

WHEREAS, this august Body has enacted Resolution No. 52 s. 1992 adopting Appropriation Ordinance No. 92-09 (Item A) which has authorized payment of P47,600.00 to Mr. Arturo Coquilla relative his road-right-ofway claim over Lot No. 8-B-3 with an area of 238 square meters at Brgy. Doña Feliza Z. Mejia, this city, which has been traversed by existing Bugo city street @ P200.-/sq. m., an approved rate granted per Resolution No. 11-91 s. 1991 of the City Appraisal Committee, in the total amount of P47,600.00;

Dona Feliza Z. Mejia, this city, at P200.-/sq. m., in the total amount P47,600.00 pursuant to Resolution No. 52 s. 1992 embodying Appropriation Ordinance No. 92-09;
