

RESOLUTION NO. 62

A RESOLUTION ADOPTING THE TEMPORARILY ADJUSTED SCHEDULE ON
FARE RATES OF MOTORIZED TRICYCLES IN ORMOC CITY.

WHEREAS, this august Body has enacted Resolution No. 101 s. 1991
reducing on purpose the fare rates of motorized tricycles operating
within the City Proper and in its immediate suburbs;

WHEREAS, the Committee on Transportation and Communications has
newly conducted a Public Hearing with the Tricycle Operators and Drivers
on April 1, 1992 at the Sangguniang Panlungsod Session Hall, this city,
on the feasibility of making temporary adjustments to the current fare
rates of motorized tricycles, for a good number of the riding public
have complained about the non-observance by many tricycle drivers of the
existing Schedule on Fare Rates few days immediately after typhoon Uring
struck Ormoc City and up to now;

WHEREAS, in said public hearing, the operators and drivers of
motorized tricycles were amenable to reasonable adjustments of the fare
rates;

WHEREAS, through the representation of the Honorable Chairman,
Committee on Transportation and Communications, the Honorable MEMBERS of
the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, is made knowledgeable
of the agreed adjustments on fare rates for motorized tricycles and, has
considered commendable said temporary adjustments of rates, hence
necessitating due response and immediate action;

NOW, THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr.,
Chairman, Committee on Transportation & Communications, jointly seconded
by mga Kagawad Arnulfo C. Salazar and Antero T. Fiel; be it

RESOLVED, to pass a resolution ADOPTING THE TEMPORARILY ADJUSTED
SCHEDULE ON FARE RATES OF MOTORIZED TRICYCLES IN ORMOC CITY;

RESOLVED, FURTHER, to reflect hereunder the Temporarily Adjusted Fare Rates of Motorized Tricycles operating in Ormoc City per Public Hearing on April 1, 1992, with emphasis on compliance of the specific conditions contained therein on the penalties for violations thereof.

DRIVERS VIOLATING THIS RESOLUTION ARE TO BE PENALIZED AS FOLLOWS:


1. First Offense - Suspension of operation for 10 days
2. Second Offense - Suspension of operation for 20 days
3. Third Offense - Suspension of Mayor's Permit
