A RESOLUTION HIGHLY REQUESTING HONORABLE SECRETARY JESUS B. GARCIA, JR., DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS, MANILA, TO REVERT TO THE CITY GOVERNMENT OF ORMOC THE LOT AND BUILDING OF THE NATIONAL TELECOMMUNICATIONS, PREVIOUSLY USED BY THE GOVERNMENT TELEPHONE SYSTEM.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor, the full text of said letter is hereunder cited as follows:

Gentlemen:

May I request that august Body to pass a resolution asking the Honorable Secretary Jesus B. Garcia, Jr. of the Department of Transportation and Communications, to revert to the Ormoc City government, the lot and building of the National Telecommunications, which used to house the Government Telephone System, Ormoc City, now not being used by said Office.

Considering that the same is not used to the purpose in which it is donated, per contract of Donation, it will be used as offices for devolved NGA, to Ormoc City.
