A RESOLUTION APPROVING RESOLUTION NO. 6, S. 1992 EMBODYING ORDINANCE NO. 2 OF THE BARANGAY COUNCIL OF TAMBULILID ENTITLED "AN ORDINANCE SUPERVISING/CONTROLLING THE OWNERSHIP AND MOVEMENTS OF DOMESTICATED ANIMALS OR OTHERWISE WHICH CAUSE DAMAGE/S TO LIFE, PROPERTY, PLANTS OR CROPS WITHIN THE BARANGAY AND FIXING PENALTIES THEREOF".


