RESOLUTION NO. 65

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN. FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A DEED OF ABSOLUTE SALE OVER LOT NO. 2363-B-6-C WITH MR. TELESFORO C. VALLE, REGISTERED OWNER OF SAID LOT WITH AN AREA OF 1,160 SQUARE METERS AT SITIO TUOS, BRGY. DONA F. Z. MEJIA OR BRGY, SAN ISIDRO (FORMERLY DAYHAGAN), ORMOC CITY AT P200.00 PER SQUARE METER. IN THE TOTAL AMOUNT OF P232,000.00 PURSUANT TO RESOLUTION NO. 60 S. · EMBODYING APPROPRIATION ORDINANCE NO. 02-11.

WHEREAS, this august Body has enacted Resolution No. 60 s. 1992 adopting Appropriation Ordinance No. 92-11 (Item A) which has authorized adopting Appropriation Ordinance ND. 92-11 (Item A) which has authorized payment of \$\mathbb{P}232,000.00 to Mr. Telesforo C. Valle relative his road-right-of-way claim over lot no. 2363-B-6-C with an area of 1,160, square meters at Sitio Tuog, Brgy. Doña F. Z. Mejia or Brgy. San Isidro (formerly Dayhagan), this city, which has been traversed by exisiting Bilwano City Street at \$\mathbb{P}200.00 per square meter, an approved rate granted per Resolution No. 11-91 s. 1991 of the City Appraisal Committee, in the total amount of \$232,000.00;

Valle, registered owner of said lot with an area of 1,160 square meters situated at Brgy. Dona F. Z. Mejia, this city, at \$200.00 per square meter in the total of P232,000.00 pursuant to Resolution No. 60 s. 1992 embodying Appropriation Ordinance No. 92-11;
