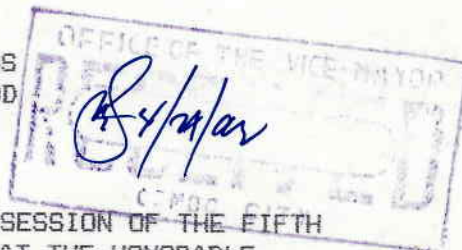

RESOLUTION NO. 66

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO GRANT, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A PERMIT TO THE KIWANIS CLUB OF METRO ORMOC, INC. ORMOC CITY, TO PUT UP A "WAITING SHED" AT THE CORNER OF LILIA AVENUE (NATIONAL ROAD) AND ABLEN STREET, THIS CITY, WITH THE CONDITION THAT ANY IMPROVEMENT THEREON THAT AFFECTS THE WAITING SHED STRUCTURE, THE KIWANIS CLUB MAY TRANSFER OR DEMOLISH IT AT THEIR OWN COST.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in receipt of a letter dated 10 April 1992 from the President of the KIWANIS CLUB OF METRO ORMOC, INC., addressed to Her Honor the City Mayor, respectfully submitting a proposal for the construction of KIWANIS WAITING SHED at the corner of LILIA AVENUE (NATIONAL ROAD) and ABLEN STREET for approval;

WHEREAS, the City Government of Ormoc interposed no objection whatsoever to the proposed construction of said waiting shed thereby granting approval to said request, however, thru the representation of the Honorable Chairman, Committee on Public Properties, any improvement thereon that affects the waiting shed structure, the KIWANIS CLUB OF METRO ORMOC, INC. may transfer or demolish it at their own cost;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Celso P. Porcadilla; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to grant, for and in behalf of the City Government of Ormoc, a permit to the KIWANIS CLUB OF METRO ORMOC, INC., Ormoc City, to put up a waiting shed at the corner of Lilia Avenue (National Road) and Ablen Street, this city, with the condition that any improvement thereon that affects the waiting shed structure, the Kiwanis Club may transfer or demolish it at their own cost;

ENACTED, April 23, 1992.

RESOLVED, FURTHER, to furnish copies of this resolution each to Her Honor, the City Mayor, the City Engineer, the Chief Inspector, Ormoc PNP and the President, KIWANIS CLUB OF METRO ORMOC, INC., -all in Ormoc City;
