RESOLUTION NO. 66

A RESOLUTION EARNESTLY URGING THE CONGRESS OF THE PHILIPPINES THROUGH THE PRESIDENT OF THE SENATE, HON. NEPTALI GONZALES AND THE SPEAKER OF THE HOUSE, HON. JOSE DE VENECIA, TO AMEND REPUBLIC ACT NO. 1161, AS AMENDED, OTHERWISE KNOWN AS THE SOCIAL SECURITY ACT OF 1954, BY PROVIDING UNEMPLOYMENT BENEFIT TO COVERED WORKERS OF SSS, WHO LOST THEIR JOBS THROUGH NO FAULT OF THEIR OWN, AND PATERNITY BENEFIT TO WORKING FATHERS-MEMBERS OF SSS AT THE TIME THEIR WIVES GIVE BIRTH, PROVIDED NO ADDITIONAL PREMIUMS SHALL BE REQUIRED FROM THE MEMBERS CONCERNED OF SSS.

WHEREAS, the SSS mission defines its corporate philosophy as follows: In line with the duty of the state to promote social justice, the SSS shall provide protection to the private sector worker and his family against contengencies which result in loss of income or financial burden, at the same time, play a significant role in the country's socio-economic development";

WHEREAS, "SSS is one of the State's main instruments for alleviating widespread poverty and thereby promoting social justice. Social Security programs become imperative to protect workers against the risks which menace the regular incomes and their ability to support themselves and their family";

WHEREAS, the benefits presently enjoyed by the workers-members of SSS as provided for in the Republic Act 1161, as amended, are: sickness, maternity, disability, death, retirement and funeral;

WHEREAS, to give real substance and meaning of social security to those workers-members of SSS who lost their jobs through no fault of their own, and to working fathers-members at the time their wives give birth, it is imperative that the corresponding benefits be extended to them; X

WHEREAS, the aforecited contengencies would result in loss of income and financial burden to the workers-members concerned of SSS;

NOW, THEREFORE on joint motion of mga Kagawad Mariano Y. Corro and Jose C. Alfaro, Jr., duly seconded by Kagawad Alfredo F. Capahi, Sr., be

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution EARNESTLY URGING THE CONGRESS OF THE PHILIPPINES THROUGH THE SENATE PRESIDENT, HON. NEPTALI GANOZALES AND SPEAKER OF THE HOUSE, HON. JOSE VENECIA, JR., TO AMEND REPUBLIC ACT 1161, AS AMENDED, OTHERWISE KNOWN AS THE SOCIAL SECURITY ACT OF 1954, BY PROVIDING BENEFIT TO COVERED WORKERS OF SSS, WHO LOST THEIR JOBS INVOLUNTARILY, AND PATERNITY BENEFIT TO WORKING FATHERS-MEMBERS OF SSS AT THE TIME THEIR WIVES GIVE BIRTH, PROVIDED NO ADDITIONAL PREMIUMS SHALL BE REQUIRED FROM THE MEMBERS CONCERNED OF SSS;

RESOLVED FURTHER, to provide copies of this resolution to the Honorable Chairman of the Social Security Commission, HON. EMETERIO C. RDA, JR. and the Administrator of the Social Security System, HON. RENATO VALENCIA, both of Quezon City;

ENACTED, September 17, 1992.

RESOLVED, FINALLY, to furnish copies of this resolution each to the Honorable Senate President Neptali Gonzales , the Honorable Speaker Jose De Venecia, Jr., - both in Congress of the Philippines, Manila; the President -/League of Provincial Governors; the President- League of Cities; His Honor, the City Mayor, Ormoc City; the President - League of Municipal Mayors, and all the mga Sangguniang Panlungsod in the Philippines, all for information and for favorable indorsement and support to hasten the proposed amendments of the Social Security Law.
