LAWYER TO ANSWER AND DEFEND CIVIL CASE NO. 3044-0 FOR
DECLARATORY RELIEF WITH PRAYER FOR PRELIMINARY INJUNCTION
AND/OR RESTRAINING ORDER, FILED AGAINST HER AND OTHER
PARTY DEFENDANTS BEFORE THE REGIONAL TRIAL COURT, THIS
CITY.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of
