RESOLUTION NO. 68

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A DEED OF RESCISSION OF SALE WITH MR. MANUEL SAINZ, JR. ET. AL., OVER LOT NO. 2, PCS 08-000131 COVERED BY TCT NO. 18581 WITH AN AREA OF 37,245 SQUARE METERS FOR RESETTLEMENT OF TYPHOON VICTIMS, SITUATED AT BRGY. LINAO, ORMOC CITY.

WHEREAS, presented for consideration is a written request of the Honorable City Mayor, this city, that he be granted with authority by this august Body to sign a Deed of Rescission of Sale with Mr. Manuel Sainz, et. al., on Lot No. 2, Pcs 08-000131 covered by TCT No. 18581 containing an area of 37,245 sq. m. at Brgy. Linao, Ormoc City;
