## RESOLUTION NO. 69

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY SOVERNMENT OF DRMOC, A DEED OF ABSOLUTE SALE OVER LOT NO. 2354-E-1 (BEING A PORTION OF LOT NO. 2354-E, PSD-08-001755 OF THE CADASTRAL SURVEY OF ORMOC) WITH MR. ROGELIO ARINO, REGISTERED OWNER OF SAID LOT WITH AN AREA OF 340 SQUARE METERS SITUATED AT RUBI VILLAGE, BRGY. PUNTA, ORMOC CITY, AT \$200.— PER SQUARE METER, IN THE TOTAL AMOUNT OF \$68,000.00 PURSUANT TO RESOLUTION NO. 60 S. 1992 EMBODYING APPROPRIATION ORDINANCE NO. 92-11.

WHEREAS, this august Body has enacted Resolution No. 60 s. 1992 adopting Appropriation Ordinance No. 92-11 (Item C) which has authorized payment of P68,000 to Mr. Rogelio Ariffo relative his road-right-ofway claim over lot no. 2354-E-1 (being a portion of lot no. 2354-E, Psd-08-001755 of the Cadastral Survey of Ormoc) with an area of 340 square meters at Rubi Village, Broy. Punta, Ormoc City at #200.00 per square meter, an approved rate granted per Resolution No. 11-91 s. 1991 of the City Appraisal Committee, in the total amount of P68,000.00;

WHEREAS, official documents evidencing absolute transfer of ownership of said property is indispensable for records file in government office/s concerned;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties jointly seconded by Kagawad Celso P. Porcadilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to sign, for and in behalf of the City Government, a Deed of Absolute Sale over Lot No. 2354-E-1 (being a portion of Lot No. 2354-E, Psd-08-001755 of the Cadasrral Survey of Ormoc) with Mr. Rogelio Ariho registered owner of said lot with an area of 340 square meters situated at Rubi Village, Brgy. Punta, Ormoc City, at 7200.00 per square meter, in the total amount of 768,000.00 pursuant to Resolution No. 60 s. 1992 embodying Appropriation Ordinance No. 92-11;
