RESOLUTION NO. 69

A RESOLUTION RESPECTFULLY URGING THE SANGGUNIANG BAYAN OF KANANGA, LEYTE, TO JOINTLY UNDERTAKE, SOONEST, WITH THE SANGGUNIANG PANLUNGSOD OF ORMOC ON THE RELOCATION OF THEIR BOUNDARIES, WITH THE COST THEREOF TO BE SHARED EQUALLY BY THEM.

WHEREAS, the boundaries of the Municipality of Kananga, Leyte and the City of Ormoc are defined by metes and bounds as these are the subjects of a cadastral survey;

WHEREAS, the said boundaries, however, are not identifiable by visible monuments and landmarks thereby causing some confusions and uncertainties as to the specific areas which truly belong to the respective territorial jurisdictions of Kananga, Leyte and the City of Ormoc;

WHEREAS, this sad state of affair is neither conducive to the development of the areas affected nor to the good relationship of the two local government units concerned;

WHEREAS, to obviate any legal complications in the future brought about by the uncertainties of the boundaries, it is to the best interest, advantage and benefit of the Municipality of Kananga, Leyte and the City of Ormoc, that their boundaries be clearly defined with visible monuments and landmarks, as soon as possible;

WHEREAS, to achieve the desired goal, it is imperative that the boundaries of Kananga, Leyte and Ormoc City be relocated by means of a resurvey to be conducted by a duly licensed geodetic engineer;

WHEREAS, equity and justice demand that the cost of the relocation of the boundaries be shared equally by both the Municipality of Kananga, Leyte and the City of Ormoc;

WHEREAS, the settlement of any boundary dispute between the Municipality of Kananga, Leyte and the City of Ormoc, be lodged jointly in their respective sangguniangs, and as much as possible, the same be settled amicably, as mandated by the provisions of Republic Act No. 7160, otherwise, known as the Local Government Code of 1991;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Celso P. Adolfo, Nestor C. Penserga, Claudio P. Larrazabal and Alfredo F. Capahi; be it

RESOLVED, to pass a resolution RESPECTFULLY URGING THE SANGGUNIANG BAYAN OF KANANGA, LEYTE, TO JOINTLY UNDERTAKE, SOONEST, WITH THE SANGGUNIANG PANLUNGSOD OF ORMOC ON THE RELOCATION OF THEIR BOUNDARIES, WITH THE COST THEREOF TO BE SHARED EQUALLY BY THEM;

RESOLVED, FURTHER, to respectfully request the Sangguniang Bayan of Kananga, Leyte to inform, soonest, the Sangguniang Panlungsod of Ormoc, their reaction to this resolution;

RESOLVED, FINALLY, to furnish copies of this resolution each to the Sangguniang Panlalawigan of Leyte, through its Provincial Secretary, and the Regional Director, Department of Interior and Local Government, both in Tacloban City; the Honorable Mayors of Ormoc City and Kananga, Leyte; the Sangguniang Bayan of Kananga, Leyte; the City Legal Officer and the DILG-ACGO Officer, both in Ormoc City;
