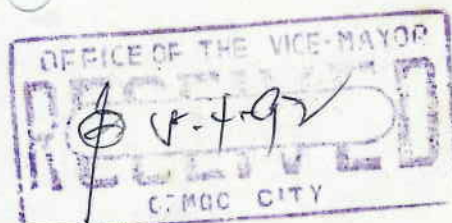

RESOLUTION NO. 71

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE
AGAINST CURRENT APPROPRIATION FOR STREET ILLUMINATION AND
LIGHTING ACCOUNT OF THE CITY ENGINEER'S OFFICE, THE AMOUNT
OF P327,327.85, TO SETTLE THE 1991 OUTSTANDING OBLIGATION
WITH LEYECO V PERTAINING TO ORMOC CITY STREET LIGHTS AND
THE CITY ENGINEER'S OFFICE MOTOR POOL ELECTRIC POWER
CONSUMPTION.

WHEREAS, presented for charging against Current Appropriation for
Street Illumination and Lighting - Account of the City Engineer's
Office, this city, is a written request of the City Engineer for an
amount of P327,327.85 to be made available for payments of the Ormoc
City Street Lights and the City Engineer's Office Motor Pool electric
power consumption from July to December, 1991;

WHEREAS, the City Budget Officer has recommended for passage of SP
resolution granting the City Treasurer with authority to charge the
aforesaid 1991 obligation against Current Appropriation;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman,
Committee on Finance, duly seconded by Kagawad Arnulfo C. Salazar; be it

RESOLVED, to approve the foregoing claim and, do, as this Body
hereby does, authorize the City Treasurer to charge against Current
Appropriation for Street Illumination and Lighting - Account of the City
Engineer's Office, the amount of P327,327.85, to settle the 1991
Outstanding Obligation with LEYECO V pertaining to Ormoc City Street
Lights and the City Engineer's Office Motor Pool electric power
consumption;


