

RESOLUTION NO. 72

A RESOLUTION AUTHORIZING THE CITY TREASURER TO AGAINST CURRENT APPROPRIATIONS FOR ILLUMINATION AND POWER SERVICES THE AMOUNT OF P154,731.41 REPRESENTING PARTIAL PAYMENT OF UNPAID ELECTRIC POWER CONSUMPTION OF THE CITY GOVERNMENT OF ORMOC.

PRESENTED for consideration is a written request of the City Treasurer on charging against Current Appropriations the amount of P154,731.41 representing unpaid electric power consumption of the City Government in its partial settlement on account of inadequacy of appropriations.

WHEREAS, this august Body finds out the foregoing claim in proper order, with the City Treasurer's Statement of Arrearages after corrections and adjustment of the LEYECO Statement of Account furnished the City Government have been made;

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the City Treasurer charge against Current Appropriations for Illumination and Power the amount of \$154,731.41 representing partial payment of unpaid electric power consumption of the City Government of Ormoc;
