

RESOLUTION NO. 73

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO WAIVE
THE OPTION IN FAVOR OF THE CITY GOVERNMENT ON NOT TO
PURCHASE THE PROPERTY WITH AN AREA OF 9,968 SQUARE METERS,
OWNED BY MR. ARMANDO M. GO AT BRGY. IPIL, ORMOG CITY.

WHEREAS, this august Body is in receipt of a letter dated 27 March 1992, addressed Her Honor, the City Mayor, from Mr. Armando M. Go respectfully requesting to execute the option on purchasing or not of the remaining portion of the property which was alleged purchase by the City Disaster Coordinating Council and/or the City Government of Ormoc from Mr. Armando M. Go;

WHEREAS, through the representation of the Honorable Chairman, Committee on Public Properties, said remaining portion of the property with an area of 9,968 square meters at Brgy. Ipil, this city, is no longer needed by the City Government on the ground that said property is located near and along a creek and therefore not ideal for a resettlement area;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, duly seconded by Kagawad Eufrocino C. Codilla, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to waive the option in favor of the City Government on not to purchase the property with an area of 9,968 square meters, owned by Mr. Armando M. Go at Brgy. Ipil, this city;
