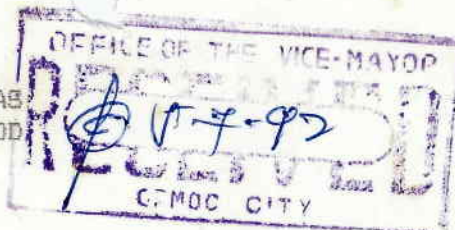

RESOLUTION NO. 74

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE OVER LOTS NOS. 2268-0-3, 2268-P AND 2268-Q, COVERED BY THE TCT. NOS. 11125, 6730 AND 6731, RESPECTIVELY, WITH MRS. FELOMINA T. VDA. DE BAUTISTA, ET. AL., AS REGISTERED OWNERS OF SAID LOTS WITH TOTAL AREA OF 15,428 SQUARE METERS, LOCATED AT BRGY. ALEGRIA, THIS CITY, AT P70.00 PER SQUARE METER AS APPRAISED BY THE CITY ASSESSOR'S OFFICE BASED ON P.D. NO. 76 AS AMENDED BY P.D. NO. 464, IN THE AMOUNT OF P1,079,960.00 OF WHICH P500,000.00 IS AUTHORIZED TO BE PAID AS PARTIAL PAYMENT PURSUANT TO APPROPRIATION ORDINANCE NO. 92-13 S. 1992.

WHEREAS, this august Body has enacted Resolution No. 72 s. 1992 adopting Appropriation Ordinance No. 92-13 (Item C) which authorized partial payment of P500,000.00 to Felomina Tomada Vda. de Bautista, Romeo T. Bautista, Rolando T. Bautista, Diosdado T. Bautista and Fatima Bautista Leones, relative to their road-right-of-way claims over Lots Nos. 2268-0-3, 2268-P and 2268-Q with the total area of 15,428 square meters at Brgy. Alegria, Ormoc City, at P70.00/square meter as appraised by the City Assessor's Office, based on Presidential Decree No. 76 as amended by Presidential Decree No. 464;

WHEREAS, official documents evidencing absolute transfer of ownership of said property is indispensable for records file in government office/s concerned;

NOW, THEREFORE, on motion of Kagawad Arnulf C. Salazar, Chairman, Committee on Public Properties, duly seconded by Kagawad Antero T. Fiel, be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to sign, for and in behalf of the City Government, a Deed of Absolute Sale over Lots Nos. 2268-0-3, 2268-P and 2268-Q covered by TCT Nos. 11125, 6730 and 6731, respectively, with Mrs. Felomina T. Vda. de Bautista, et. al., as registered owners of said lots with a total area


of 15,428 square meters located at Brgy. Alegria, this city, along existing Lauaan, Baticulin, Don F. Larrazabal, Acle and Narra city streets at P70.00/square meter as appraised by the City Assessor's Office, based on Presidential Decree No. 76 as amended by Presidential Decree No. 464, in the amount of P1,076,960.00 of which P500,000.00 is authorized to be paid as partial payment pursuant to A.O. 92-13 s. 1992;
