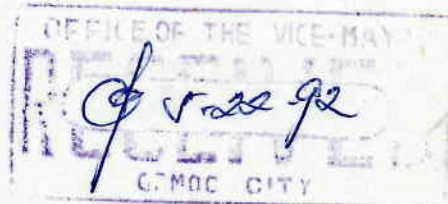

RESOLUTION NO. 76

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN AND ACCEPT, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOG, AS DONEE, A DEED OF DONATION WITH P & A LARRAZABAL ENTERPRISES, AS DONOR, FOR A TEN (10) METER ROAD WITH AN AREA OF 714 SQUARE METERS OF LOT NO. 827 ADJOINING THE ORMOG CITY TENNIS COURTS, THIS CITY.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor requesting for authority to accept the donation from P & A Larrazabal Enterprises and, to sign said deed of donation for and in behalf of the City Government, as Donee for a ten (10) meter road with an area of 714 square meters of Lot No. 827, adjoining the Ormoc City Tennis Courts, this city;

WHEREAS, the said donation is made out of the donor's civic spiritedness and generosity to the City Government to greatly enhance the beautification of the city's parks and plazas for the benefit of the city;




