A RESOLUTION THANKING THE EMERGENCY RESCUE UNIT FOUNDATION (ERUF), CEBU CITY, FOR THEIR ASSISTANCE IN THE RESCUE OPERATIONS IN ORMOC CITY WHICH WAS HEAVILY DAMAGED BY TYPHOON URING.

WHEREAS, Ormoc City was in a very pathetic state of ruins, so miserable and horrible was the plight of the Ormocanons during and days immediately after violent typhoon Uring struck the said place on November 5, 1991, with turbulent waters, at the height of the flashflood, having surged in all the city streets, leaving very enourmous loss of lives and terrible destructions to properties and infrastructures;

WHEREAS, the Emergency Rescue Unit Foundation (ERUF) of Cebu was among the earliest rescue operations teams to have responded and rendered the much needed humanitarian assistance and services in badly damaged Ormoc City;

WHEREAS, this august body has considered the good Samaritan help, services and accomplishments rendered by ERUF very monumental and much worthy to reckon with, hence, must be accorded with due course of action;
