

RESOLUTION NO. 85

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ENTER INTO A CONTRACT AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE WITH THE BANK OF THE PHILIPPINE ISLANDS IN THE AMOUNT OF P85,640.40 DVER LOT NO. 17168 SITUATED AT BRGY. BANTIGUE, ORMOC CITY, WITH AN 1,587 SQUARE METERS @ P50.00/SQUARE INCLUSIVE OF INCIDENTAL EXPENSES ON SAID SALE.

WHEREAS, this august Body has enacted Resolution No. 84 s. 1992 adopting Appropriation Ordinance No. 92-18 which authorized payment of P85,640.40 to the Bank of the Philippine Islands (BPI) on a purchase of Lot No. 17168 with an area of 1,587 square meters at Brgy. Bantigue, this city, @ P50.00/sq. meter inclusive of incidental expenses relative to said sale, the said property is intended to be used as Barangay site of Barangay Bantigue;

official documents evidencing absolute transfer ownership of said property is indispensable for records file in government office/s concerned;
