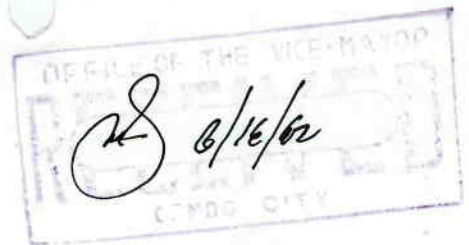

RESOLUTION NO. 86

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ENTER INTO A 25 - YEAR LEASE CONTRACT, FOR AND IN BEHALF OF THE CITY GOVERNMENT, WITH THE VETERANS FEDERATION OF THE PHILIPPINES, ORMOC CITY POST, OVER THE VACANT CORNER LOT ACROSS THE STREET PRESENTLY OCCUPIED BY THE ORMOC CITY POST OFFICE WITH AN AREA OF 500 SQ. M. LOCATED AT THE GOVERNMENT CENTER, ORMOC CITY.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of an unnumbered resolution from the Veterans Federation of the Philippines, Ormoc City Post, entitled "Resolution requesting the Honorable Sangguniang Panlungsod through the Honorable City Mayor, Ma. Victoria L. Locsin, for an assignment of a portion of a City Lot in which a Veterans Center Building will be constructed for the World War II Veterans";

WHEREAS, this City Government has recommended that the vacant corner lot across the street presently occupied by the Ormoc City Post Office with an area of 500 sq. m. located at the Government Center, Ormoc City, be the subject of said lease, on the condition that the lease rental is P1.00 per year and that the building should be constructed within two years time from the approval of said lease, otherwise, the said lot will be reverted to the City Government;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, duly seconded by Kagawad Edgar Z. Palugod; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to enter into a 25-year-lease contract, for an in behalf of the City Government, with the Veterans Federation of the Philippines, Ormoc City Post, over the vacant corner lot across the street presently occupied by the Ormoc City Post Office, with an area of 500 sq. m. located at the Government Center, Ormoc City;

ENACTED, June 11, 1992.




