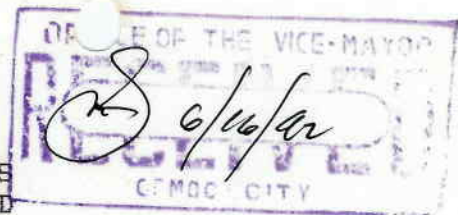

RESOLUTION NO. 89

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN,
FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF
ABSOLUTE SALE OVER LOT NO. 2353-B-2 WITH THE HEIRS OF
RAFAEL DRILLANO, REPRESENTED BY THEIR ATTY.-IN-FACT
ESCOLASTICA MANULAT, WITH AN AREA OF 1,059 SQUARE METERS,
LOCATED AT LOOC, BRGY. LINAQ, ORMOC CITY AT P230.00 PER
SQ. M., IN THE TOTAL AMOUNT OF P243,570.00.

WHEREAS, this august Body is in receipt of a letter dated 01 June,
1992 from the Honorable City Mayor, requesting said Body for an
authority to enter into a contract of absolute sale with the heirs of
RAFAEL DRILLANO, represented by their Atty.-In-Fact ESCOLASTICA MANULAT,
on a portion of land Lot No. 2353-B-2 situated at Looc, Brgy. Linao,
Ormoc City, appraised at P230.00 per square meter in connection with the
proposed 20-meter road at Barangay Linao, this city, as part of the city
government's on-going projects;

WHEREAS, the City Budget Officer has recommended that the payment
for said lot be made in staggered basis on the reason that the city has
incurred heavy expenditures as a result of typhoon "Uring" thereby
recommending the amount of P100,000.00 as partial payment to be included
in the Revised 1992 Annual Budget;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, duly
seconded by Kagawad Rodolfo L. Rivilla, Jr., be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City

Drillano, represented by their Atty.-In-Fact Escolastica Manulat, with
an area of 1,059 sq. m., located at Looc, Brgy. Linao, Ormoc City at
P250.00 per sq. m., in the total amount of P243,570.00;
