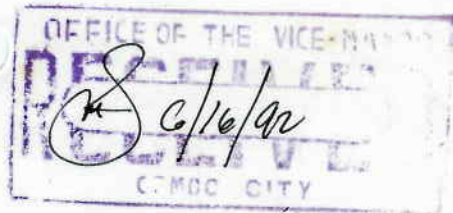

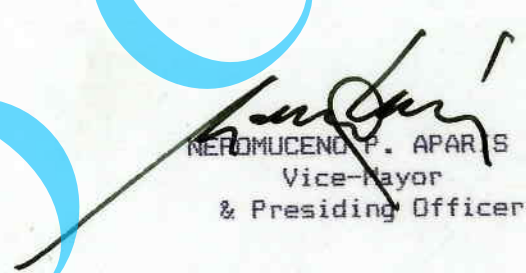

ENACTED, June 11, 1992.

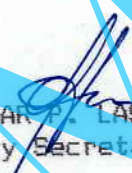
