A RESOLUTION ALLOWING THE TEMPORARY CLOSURE OF THE ROAD IN-
BETWEEN BUS TERMINAL AND PHILIPPINE PORTS AUTHORITY (PPA)
FOR THE DURATION OF THE CITY FIESTA CELEBRATION, TO BE
UTILIZED AS SPACE FOR AMUSEMENTS AND RIDES.

WHEREAS, in connection with the celebration of the Ormoc City
Fiesta 1992, the City Government of Ormoc, as part of its tradition,
utilizes the Ormoc Bus Terminal as its venue for the different fiesta
related activities;

WHEREAS, currently, the Fifth Sangguniang Panlungsod in SESSION has
allowed the temporary closure of the road in-between the Bus Terminal
and the Philippine Ports Authority effective immediately for the
duration of the City Fiesta Celebration which is until June 30, 1992, to
be utilized as space for amusements and rides;

NOW, THEREFORE, on motion of Kagawad Celso P. Adolfo, Majority
Floor Leader, duly seconded by Kagawad Rodolfo L. Rivilla, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to allow the temporary closure
