RESOLUTION NO. 06

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO EXTEND
THE DEADLINE FOR REGISTRATION/RENEWAL OF PERMITS/LICENSING
OF BUSINESSES FROM JANUARY 20 TO FEBRUARY 28, 1993.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of
a letter dated 11 January 1993 from the Ormoc Filipino Retailers'
Association addressed His Honor, the City Mayor and, the latter having
endorsed the same to this august Body for appropriate action, said
letter having requested for extension of the Deadline for
Registration/Renewal of Permits/Licensing of Businesses from January 20
to February 28, 1993, alleging therein the tight financial difficulties
encountered by members of the association in raising sufficient funds
for payment of the different taxes;

WHEREAS, in view of the aforecited request, this august Body has
considered reasonable to temporarily suspend the operation of Section
1.2.1.4 of Tax Ordinance No. 1 s. 1976, otherwise known as the "Ormoc
City Revenue Code of 1977", fixing the first twenty (20) days of January
to pay tax obligations to the government, to provide not only the
members of the aforementioned retailers association, but also all
taxpayers with ample time to meet the various requirements relative tax
obligations;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman,
Committee on Finance, jointly seconded by mga Kagawad Jose C. Alfaro,
Jr. and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City
Mayor to extend the Deadline for Registration/Renewal of
Permits/Licensing of Businesses from January 20 to February 28, 1993;
