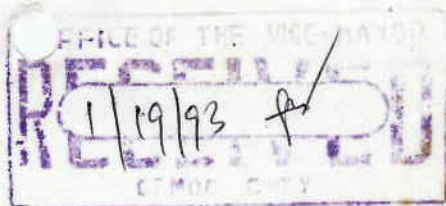

RESOLUTION NO. 07

A RESOLUTION APPROVING RESOLUTION NO. 3 s. 1993 OF THE CITY
DEVELOPMENT COUNCIL RE LOCAL DEVELOPMENT PLAN FOR 1993-
1998 OF THE CITY OF ORMOC AND ENDORSING THE SAME TO THE
REGIONAL DEVELOPMENT COUNCIL, NEDA, PALO, LEYTE.

WHEREAS, this august Body is in receipt of Resolution No. 3 s. 1993
from the City Development Council, Ormoc City, entitled A RESOLUTION
REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF
LOCAL DEVELOPMENT PLAN FOR 1993-1998 OF THE CITY OF ORMOC AND ENDORSING
THE SAME TO THE REGIONAL DEVELOPMENT COUNCIL, NEDA, PALO, LEYTE;

WHEREAS, the said resolution has stated that the Local Development
Plan for 1993-1998, as formulated by the City Planning & Development
Office in coordination with all barangay chairmen, is a Medium Term Plan
of the City of Ormoc which anticipates the possibility of overlooking
some immediate plans and programs during the planning period and may
later be perceived as priority in the coming years, and, all proposed
priority plans, programs and projects not allocated for funding during
the implementation year due to financial constraints will be
automatically recommended and considered as priority in the next
succeeding year but will be subject for further evaluation and study as
to its urgency and necessity in the barangay areas concerned;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng
ORMOC, in SESSION, have considered the rationale and spirit behind the
Local Development Plan (1993-1998) for the city as encouraging and very
reasonable, aside from the fact that the Constitution of the Philippines
has mandated all local government units in the preparation of local
development plans;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman,
Committee on Finance, jointly seconded by mga Kagawad Jose C. Alfaro,
Jr. and Fernando P. Parrilla; be it

RESOLVED, to pass a resolution APPROVING RESOLUTION NO. 3 S. 1993 OF THE CITY DEVELOPMENT COUNCIL RE LOCAL DEVELOPMENT PLAN FOR 1993-1998 OF THE CITY OF ORMOC AND ENDORSING THE SAME TO THE REGIONAL DEVELOPMENT COUNCIL, NEDA, PALO, LEYTE;
