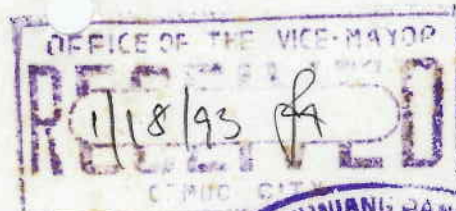

RESOLUTION NO. 08

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE SECRETARY OF  
THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO SET  
ASIDE THE AMOUNT OF P10 MILLION FROM THE APPROPRIATED  
AMOUNT FOR 1993 SCHOOLBUILDING PROGRAMS FOR EASTERN  
VISAYAS SPECIFICALLY FOR ORMOC CITY.

WHEREAS, the Department of Education, Culture and Sports has  
earmarked a P2.3 Billion for its 1993 schoolbuilding programs (Source:  
Manila Bulletin December 28, 1992);

WHEREAS, from the P2.3 Billion which the DECS has set aside for its  
1993 schoolbuilding programs, P53,346,000.00 is allocated for Eastern  
Visayas wherein Ormoc City is a part of;

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc in SESSION has  
requested the amount of P10 Million from the P53,346,000.00 which is  
allocated for Eastern Visayas for purposes of construction and  
rehabilitation of its schoolbuildings which were heavily damaged by  
typhoon "Uring" last November 5, 1991 and to accommodate the rising  
number of enrollees specifically in Ormoc;

NOW, THEREFORE, on motion of Kagawad Benjamin B. Lladoc, severally  
seconded by Kagawad Jose C. Alfaro, Jr., Nestor C. Penserga, Fernando P.  
Parrilla, Alfredo F. Capahi and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly request the  
Honorable Secretary of the Department of Education, Culture and Sports  
to set aside the amount of P10 Million from the appropriated amount for  
1993 schoolbuilding programs for Eastern Visayas specifically for Ormoc  
City;

ENACTED, January 14, 1993.

RESOLVED, FURTHER, to furnish copies of this resolution each to the Honorable Secretary, Department of Education, Culture and Sports (DECS) Manila; the Regional Director, DECS, Tacloban City, His Honor, the City Mayor and the Schools Division Superintendent, Ormoc City;

CARRIED UNANIMOUSLY.


