TO SIRN, FOR AND IN BEHALF OF THE CITY GOVERNATOR OF GRANC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR THE INTERNATION OF THE UNICEF ASSISTED PROJECT "BREAKING GROLNIX FOR CLYMMUNITY ASTION ON CHILD LABOR" (BGCACL) IN ORMOC CITY

WHENEAS, the long-term goal of the UNICEF assisted project, "Breaking Ghound for Community Action on Child Labor", (BGCACL), is to develop and implement strategies and interventions which seek to project the Filipins working child against abuse and exploitation and promote his hights and welfare in Philippine Society;

WEREAS, in line with the objectives and spirit of Republic Act 7100, otherwise known as the 1791 Local Government Code— on decentralizing and devolving some functions and services of concerned national offices to the LGUs, there is a need to integrate and institutionalize the planning and implementation of the BGCAVL programs/projects into the meanstream of development planning and efforts of the LGUs that will uplift the socio—economic life and promote the general well-being of working children and their families;

WHEREAS, in view of the foregoing valid and sound premises and, in consideration with the written request of the Honorable City Mayor on authorizing him to sign in behalf of the City Government a Memorandum of Agreement with DOLE relative to the implementation of UNICEF assisted BGCACL project in Ormoc City, this august Body considers reasonable on authorizing the Chief Executive of Ormoc to sign said 'Memorandum of Agreement;
