RESOLUTION NO. 14

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORmoc, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR THE IMPLEMENTATION OF THE UNICEF ASSISTED PROJECT "BREAKING GROUND FOR COMMUNITY ACTION ON CHILD LABOR" (BGCACL) IN ORmoc CITY.

WHEREAS, the long-term goal of the UNICEF assisted project, "Breaking Ground for Community Action on Child Labor", (BGCACL), is to develop and implement strategies and interventions which seek to protect the Filipino working child against abuse and exploitation and promote his rights and welfare in Philippine Society;

WHEREAS, in line with the objectives and spirit of Republic Act 7160, otherwise known as the 1991 Local Government Code- on decentralizing and devolving some functions and services of concerned national offices to the LGUs, there is a need to integrate and institutionalize the planning and implementation of the BGCACL programs/projects into the mainstream of development planning and efforts of the LGUs that will uplift the socio-economic life and promote the general well-being of working children and their families;

WHEREAS, in view of the foregoing valid and sound premises and, in consideration with the written request of the Honorable City Mayor on authorizing him to sign in behalf of the City Government a Memorandum of Agreement with DOLE relative to the implementation of UNICEF assisted BGCACL project in Ormoc City, this august Body considers reasonable on authorizing the Chief Executive of Ormoc to sign said Memorandum of Agreement;

NOW, THEREFORE, on motion of Kagawad Celso P. Adolfo, Chairman, Committee on Health, Public & Social Welfare, Women & Family, jointly seconded by mga Kagawad Benjamin B. Lladoc and Sotero M. Pepito; be it
