CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE HOUSING AND LAND USE REGULATORY BOARD FOR THE PURPOSE OF TRAINING THE CITY TECHNICAL PERSONNEL IN THE PROCESSING OF SUBDIVISION PLANS PURSUANT TO R.A. NO. 7160.

WHEREAS, this august Body is in receipt of an undated letter from the Honorable City Mayor addressed to the Honorable Vice-Mayor and Presiding Officer the full text of which is herein cited as follows:

The Housing and Land Use Regulatory Board (HLURB) is in the process of devolving their functions to the City Government of Ormoc pursuant to the pertinent provisions of R.A. 7160. In this regard, the representation of the HLURB has submitted to the undersigned the necessary and corresponding Memorandum of Agreement for this purpose.

Aside from the fact that this will facilitate processing and approval of subdivision plans for residential, commercial, or industrial purposes, the same will earn more revenues for our city.

May I, therefore, request you to pass a resolution authorizing me to sign the attached Memorandum of Agreement.

Your preferential and favorable action in this regard is highly appreciated.
