RESOLUTION NO. 20

A RESOLUTION TEMPORARILY DECLARING A PORTION OF OSMENA STREET FROM THE CORNER OF REAL STREET TO BARANGAY DON FELIPE LARRAZABAL AS A ONE-WAY TRAFFIC ROAD FOR VEHICLES GOING OUT OF THE CITY FROM 5:00 AM TO 7:00 PM WHICH SHALL TAKE EFFECT IMMEDIATELY UPON ITS APPROVAL AND ALLOWING VEHICLES COMING IN THE CITY PROPER TO TAKE THE PUNTA-ALEGRIA ROAD, PENDING THE COMPLETION OF CANTUBO BRIDGE.

WHEREAS, the bridge connecting Real Street and Lilia Avenue is still impassable necessitating the vehicles to pass Alegria Bridge and/or the spillway connecting Osmeña extension and the road along Barangay Don Felipe Larrazabal;

WHEREAS, most of the portion of Osmeña extension and the road along Barangay Don Felipe Larrazabal is a narrow strip which can easily be congested by in-coming and out-going vehicles causing danger to the lives and limbs of commuters and pedestrians alike;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., duly seconded by mga Kagawad Claudio P. Larrazabal and Celso P. Adolfo; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to temporarily declare a portion of Osmeña Street from the corner of Real Street to Brgy. Don Felipe Larrazabal as a one-way traffic road for vehicles going out of the city from 5:00 AM to 7:00 PM which shall take effect immediately upon approval and allowing vehicles coming in the city proper to take the Punta-Alegria road, pending the completion of Cantubo bridge;

ENACTED, January 28, 1993.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor, the Chief Superintendent, PNP Ormoc Headquarters, Chief Superintendent, PNP, Metrodiscom and to all others concerned, -all in Ormoc City;
