A RESOLUTION DECLARING CARLOS TAN STREET FROM J. NAVARRO TO SAN PEDRO STREETS AS DNE WAY STREET FROM 6:00 A.M. TO 5:00 DUATNO SCHOOL DAYS.

the main entrance and exit of the Ormoc City Central of along Cyrlos Tan Street between the intersection of J. School is located Navarro and San Franc Streets;

WHERE (5) Orticle 3 Sec. 458 paragraph 5, subparagraph (vi) of the Government Code provides that the Sangguniang Panlungsod shall:

i) Requiste Traffic on all streets and bridges; prohibit encroachments on obstacles thereon and, when necessary in the interest of public welfare, authorize the removal encroachments and illegal construction in public places;

WHEREAS, there is a resolution of the Barangay Council of District 18 requesting the Sangguniang Fanlungsod to declare the above mentioned portion of the street a one-way street during school days for the safety of the students and other pedestrians;

NOW, THEREFORE, above premises considered and realizing validity and importance of the requested resolution, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Police, Fire and Public Safety, jointly seconded by Kagawad Sotero M. Pepito and Angelyn R. Paca; be it

RESOLVED, to declare Carlos Tan St. from J. Navarro to San Pedro Sts. as one-way street from 6:00 A.M. to 5:00 P.M. during school days;

RESOLVED, FINALLY, to furnish copies of this resolution each to His Honor, the City Mayor; the City Engineer; the Chief of Police, Ormoc City PNP Station; the Principal of the OCCS; the Barangay Chairmen of Barangay District XVIII and Barangay District X, -all in Ormoc ity;
