RESOLUTION NO. 04

A RESOLUTION APPROVING CAC EXECUTIVE COMMITTEE'S RESOLUTION NO. 1. 6. 1994, ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF THE CONSTRUCTION OF COOB ROAD IN THE AMOUNT OF CIVE HUNDRED THOUSAND PESOS (P500,000.00) TO THE RECLANMENTING OF BAS BIVER NEAR BRGY. MATICA-A IN THE AMOUNT OF A500,000.00, AND REQUESTING THE HONORABLE SANGGOVIAND PANEUMOSOD NG ORMOC FOR APPROVAL OF THE SAME".

WHEREOS, this august Body is in receipt of Resolution No. 1 s. 1994 from the CDC Executive Committee, entitled "A Resolution approving the Realignment of the Construction of Coob Road in the amount of Five Hundred Thausant Pesos (#500,000,00) to the Rechannelling of Bao River near Brgy. Matica-a in the amount of #500,000.00, and requesting the Nonorable Sangguniang Panlungsod ng Ormoc for approval of the same";

MEREAS, SP Resolution No. 131 s. 1992 which approved CDC Resolution No. 8 s. 1992 re Local Development Plan for 1993-1998 and the 20% Economic Development Projects for 1993, had listed thereunder as one approved project the Construction of Coob Road amounting to P500,000.00;

WHEREAS, the contentions of the CDC Executive Committee's decision in realigning the ₱500,000.00 from the Construction of Coob Road project to Rechannelling of Bao River at Brgy. Matica-a are as follow:

- a) The Construction of Coob road has not been implemented, for its road right of way is still under negotiation.
- b) The rechannelling of Bao River near Brgy. Matica-a is considered with priority and needs immediate implementation "since the banks of said river has been heavily eroded due to the recent typhoon that hit the city which greatly endanger the residents of the area."

MATINA A IN THE AMOUNT OF #500,000.00, AND REQUESTING THE HONORABLE SACSOLVIANG PANLUNGSED NG ORMOC FOR APPROVAL OF THE SAME";
