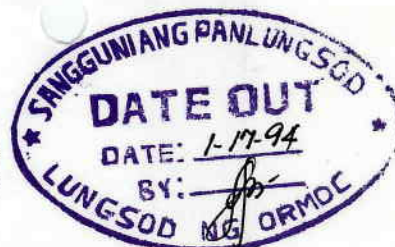

#### RESOLUTION NO. 07

A RESOLUTION APPROVING RESOLUTION NO. 20 S. 1993 EMBODYING  
TAX ORDINANCE NO. 93-003 OF THE BARANGAY COUNCIL OF  
BARANGAY DISTRICT 10, ENTITLED "AN ORDINANCE IMPOSING  
TAXES ON STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS,  
PRIVILEGE PANEL AND OTHER OUTDOOR ADVERTISEMENT, BARANGAY  
CLEARANCE AND BARANGAY PERMIT".

WHEREAS, this august Body is in receipt of Resolution No. 20 s.  
1993 embodying Tax Ordinance No. 93-003 of the Barangay Council of  
Barangay District 10, this city entitled "AN ORDINANCE IMPOSING TAXES ON  
STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVILEGE PANEL AND OTHER  
OUTDOOR ADVERTISEMENT, BARANGAY CLEARANCE AND BARANGAY PERMIT";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited Ordinance at issue (and all other ordinances of the barangays  
in Ormoc City) is, by law granted the Power of Review on whether the  
said Ordinance is consistent with and city X X X ordinances. (Sec. 57
