WHEREAS this rugust body is in receipt of Ordinance No. 02 s. 1994 of the Barangay Council of Brgy. Don Felipe Larrazabal, this city, entitled "Prohibiting the writings or printing of any kind on the barangay properties and providing penalty for violation thereof";
